**ALUMNI VOTING DELEGATE
PROCEDURE**

**FROM THE NATIONAL BYLAWS AS AMENDED THROUGH THE 200:
NATIONAL CONVENTION**

Article XII-Alumni, Section 3. Regional Alumni Councils.

- (1) There shall be an Alumni Council in each Region of Alpha Phi Omega formed and chaired by the National Alumni Relations and Internal Volunteer Development Committee Member for that Region.
- (2) The Regional Alumni Council shall be composed of at least one Alumni Member from each recognized alumni association within the Region and at least one Alumni Member-at-large from the Region, appointed by the Regional Alumni Council Chair. The council shall also include at least one Alumni Member-at-large from each Section, appointed by the Regional Alumni Council Chair and approved by the respective Sectional Chair, in order to represent the interests of those alumni not affiliated with a recognized alumni association within said Region.
- (3) The Regional Alumni Council shall aid local alumni associations within the region, aid the National Alumni Association in locating and maintaining contact with Alumni within the Region, coordinate all regional alumni meetings and activities, and elect the Alumni Voting Delegate to the National Convention with the certification of the Regional Director. It shall also serve as an advisory board to the Regional Director concerning issues related to alumni affairs.

FROM THE NATIONAL BOARD OF DIRECTORS POLICY MANUAL

Section 19. Alumni Voting Delegates.

Regional Alumni Councils elect Alumni Voting Delegates. A simple majority vote is required when a quorum is present. Nominations should be solicited from Alumni within the Region. One of the following methods of election may be used:

- (1) Open elections at a meeting of the members of the Regional Alumni Council to which all members of the council have received two (2) weeks notice. A quorum for this procedure is defined as a majority of the members of the Regional Alumni Council.
- (2) A mail, e-mail or phone ballot of the members of the Regional Alumni council. All members of the council must be given adequate opportunity (at least two weeks) to participate in the election. A quorum for this procedure is defined as two-thirds of the members of the Regional Alumni Council.
- (3) Any other appropriate method that has received prior approval by the Regional Director and the National Alumni Relations/Internal Volunteer Development Program Director. A quorum for this procedure is defined as two-thirds of the members of the Regional Alumni Council.

It is recommended that at least one alternate delegate be elected along with the voting delegate. The voting procedure used by the Regional Alumni Council must be documented by the Regional Alumni Representative and by the Regional Director using the Regional Alumni Voting Delegate Authorization Form prior to the beginning of the National Convention.
